Article 12 – Respect for cultural diversity and pluralism

The importance of cultural diversity and pluralism should be given due regard. However, such considerations are not to be invoked to infringe upon human dignity, human rights and fundamental freedoms, nor upon the principles set out in this Declaration, nor to limit their scope.

The **4th World Bioethics Day** is dedicated to Respect for Cultural Diversity and Pluralism. In a workshop on Friday, 18 October 2019, we will discuss several aspects of this topic and their relevance in the area of health.
